WHEN THE MOMENT FOR CHANGE IS NOW



Women human rights defenders (WHRDs) often have only hours or days to respond to opportunities or challenges that advance or protect women's human rights - they simply cannot wait for traditional funding cycles. It is in those moments that a threatened activist's life can be protected, escalating violence can be mitigated, or a law enacted that changes the lives of women for generations to come. For this reason, Urgent Action Fund accepts grant requests in any language 365 days a year, responds within 72 hours, and often provides funding within a week.

Rapid Response Grants (RRG) are made in three categories:

- Strategic interventions in situations of armed conflict, escalation of violence or political instability
- Protection and security for women human rights defenders and their families
- Potentially precedent-setting legal or legislative actions, or actions that aim to protect a precedent that has already been set

UAF is able to respond this rapidly and effectively with the support of an international activist Board of Directors, and the volunteer efforts of a worldwide network of activist advisors who provide local context for the situation and can address the strategic importance of the proposed initiative. It is this extensive web of women whose generosity of spirit enables UAF's unique funding to exist.

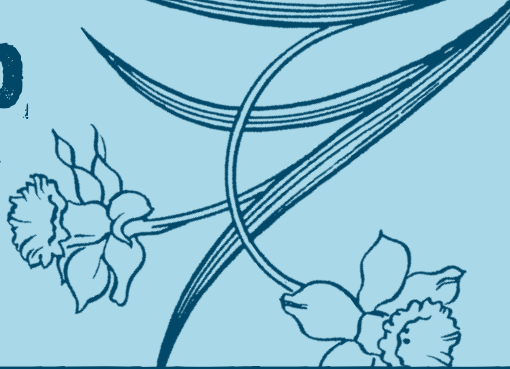
Complementing the RRG program, UAF also serves as witness, to learn from and record the work of WHRDs through our **Research, Publications and Advocacy program**. What is seemingly a solitary undertaking oftentimes has deep local and broad transnational resonance. We draw inspiration from the courage and resilience of women around the world. In turn, UAF seeks to strengthen activists with publications that illuminate their work, and initiate change in the way activists and the philanthropic community understand and support activism.

BRIDGE OF FRIENDSHIP KARTLOSI



Georgia—September 2008. Tensions between Georgia and Russia erupted over the contested autonomy and independence of South Ossetia. In the fighting that ensued, women were killed, raped, injured, and thousands more displaced. Even prior to the escalation of violence, women human rights defenders were operating in an environment where human rights violations, violence against women and trafficking of women presented formidable challenges and obstacles to the advancement of human rights.

As UAF began receiving messages from activists in Georgia it became clear that the speed of the conflict exacerbated the difficulty in strategizing an effective response. Although humanitarian needs predominated the funding requests circulating within the donor community, within hours, women were also organizing and affecting change. Activists were not just saving lives,

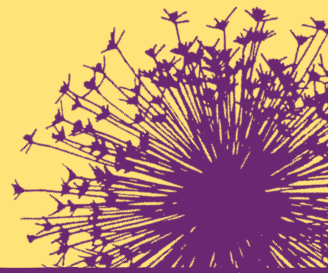
but also protesting the violence, creating safe spaces for WHRDs to respond, and documenting the conflict for use in tribunals and other reconstruction efforts.

Understanding the invaluable importance of monitoring the violence and human rights violations against women and girls, Bridge of Friendship Kartlosi requested UAF funds to document rights violations that were being perpetrated. In addition, they felt it was important to complement the documentation with direct action and therefore organized a peace march to raise public awareness regarding women's experiences during the war. Through their efforts and in collaboration with other women's organizations, Kartlosi was also able to initiate a Women's Anti-War Movement that continues to organize peaceful actions.

ASIA PACIFIC NETWORK OF SEX WORKERS



Cambodia—April 2008. When policies and legislation are developed without the participation of the communities they will impact, it can result in institutionalized human rights violations.

In an effort to curb human trafficking, a law was recently passed that criminalizes prostitution in Cambodia. The law was drafted in the United States as a model for South and Southeast Asian governments' counter-trafficking strategies. It resulted in sex workers in Phnom Penh being rounded up by police and taken to government-run "rehabilitation centers" where they were routinely beaten and raped by police and guards. The women were detained without charge in unsanitary detention centers and only allowed to leave if they bribed the guards and paid a fine. Rather than decreasing human trafficking, the Asia Pacific Network of Sex Workers (APNSW) reported to

UAF that the practice of releasing women to anyone who paid the price (the "fine") actually increased trafficking and debt bondage. At the same time, the United States was encouraging other South and Southeast Asian States to pass a similar law.

In an effort to prevent further adoption of this harmful legislation, APNSW requested UAF funds to organize sex workers and civil society groups in opposition to the law. Through providing immediate medical and mental health needs for women released from the "rehabilitation centers," APNSW was able to collect testimonies of the detained women to use in an awareness-raising campaign, and to organize meetings with the U.S. delegation and other United Nations representatives to emphasize the brutal impact of Cambodia's anti-trafficking measure.

All of the activities took place as a direct result of the UAF grant. In particular the timing of the grant and the speed at which it was processed were key to it having had such an enormous impact. We believe that of all the grants the Asia Pacific Network of Sex Workers has had from various donors this grant had the most impact.

ORGANIZATION Q

THE 26-MINUTE GRANT

Bosnia—September 2008. While a response within 72-hours makes UAF's Rapid Response Grantmaking unique from traditional funding cycles, some situations require an even faster response.

In September 2008, UAF received a call from Organization Q (OQ), an LGBTIQ rights group, regarding an escalation of threats before their upcoming Queer Sarajevo Festival. Over the previous 12 months, OQ had been planning a major arts festival, with widespread publicity throughout Europe. As the festival approached, the organization received mounting hate speech messages and threats to their safety by religious extremists who wanted the festival canceled.

Despite the threats of disruption, violence and death, OQ refused to be intimidated into canceling the festival. They requested funds for intensified

security in order to ensure participants' safety and the festival's success. Within **26 minutes** of receiving this urgent call, the UAF grantmaking team was able to consult with two funders familiar with OQ's work for necessary endorsements, approve the grant with UAF's Executive Director, and make arrangements to wire the funds.

Unfortunately, despite increased security, during the first night of the festival there were attacks on the attendees. The next day, instead of following the original program, festival organizers held a press conference publicly denouncing the violence. They announced that due to the attacks, the gathering was no longer about arts and culture, but was now political. Although increasing harassment and threats continued and the festival was forced to stop its activities, OQ was proud that the event served as a high-profile political protest against violence and discrimination in Bosnia.

SUSTAINING ACTIVISM AND INTEGRATED SECURITY

All around the world, women defend the rights of individuals and communities facing oppression, discrimination and conflict. Their work is powerful and controversial, and it is often met with bitter and violent opposition, leading to burn out and illness. UAF is an activist fund that prioritizes the sustainability and wellbeing of individual women human rights defenders, their organizations, and transnational women's activism.

Our Sustaining Activism and Integrated Security projects synergistically enhance the ability of women activists to protect and sustain themselves and their organizations, while increasing recognition and resources for their work. UAF helps make the sphere of women's rights activism more visible, real and respected.

What's the Point of Revolution If We Can't Dance? and *Insiste Persiste*

Resiste Existe: Women Human Rights Defenders' Security Strategies, were both published by UAF in 2008. They highlight the stories and the strategies of women who continue to struggle, achieve and believe in the possibility for change – despite the challenges and risks, and the extremely limited funds and support available for their work.

The publications, in multiple languages, are taking on a life of their own in the hands of women activists. In concert with UAF's Integrated Security/ Sustaining Activism workshops on three continents, and public dialogues on international panels and presentations, these concepts and tools are resonating with activists and their allies as they embark on their individual and collective journeys toward sustainability.

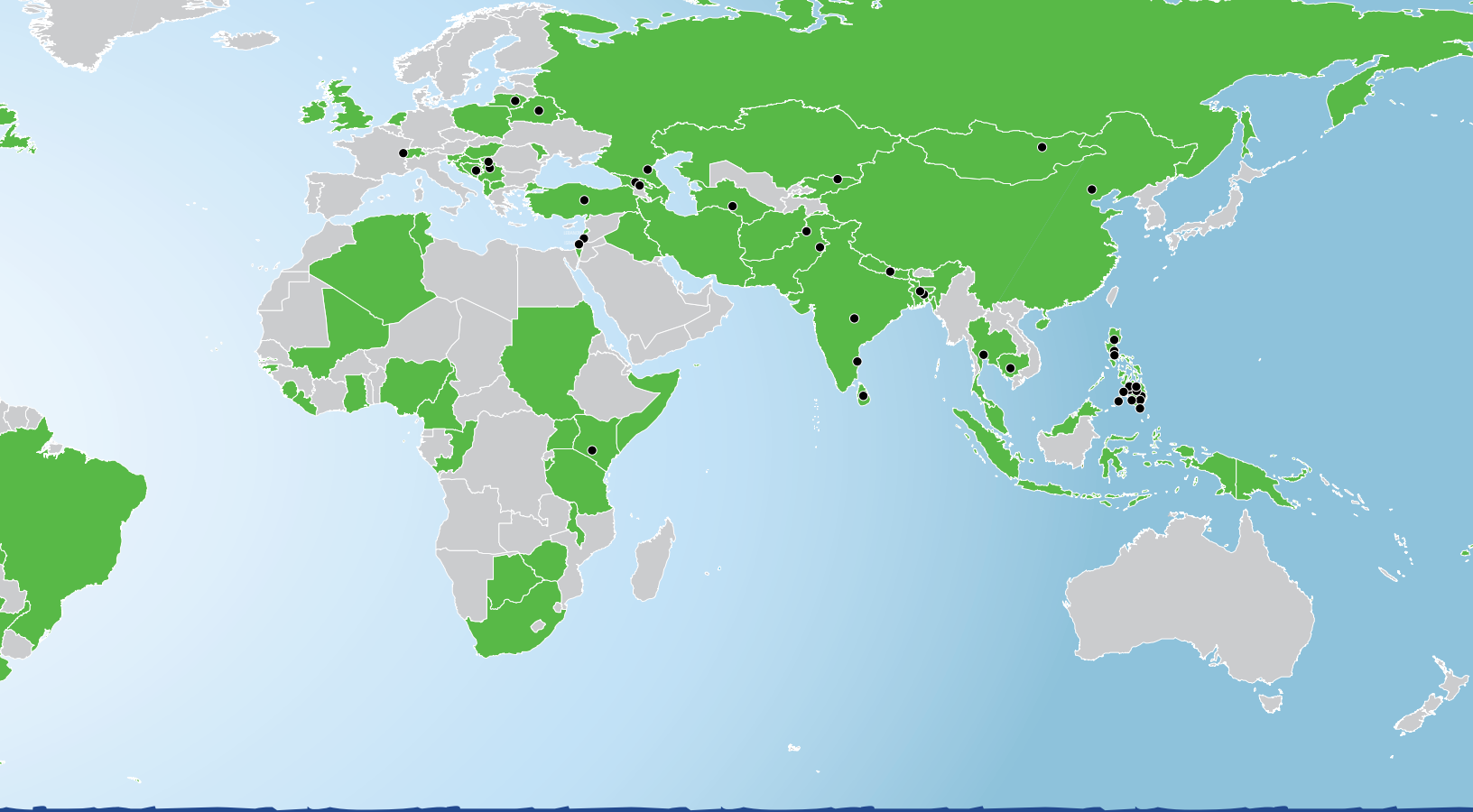

OVER THE PAST TEN YEARS, UAF HAS MADE MORE THAN 700 RAPID RESPONSE GRANTS, FOR A TOTAL OF MORE THAN \$3 MILLION. UAF MADE 124 GRANTS IN 2008 – REPRESENTING A 55% INCREASE FROM 2007.

Since 1997, UAF has made grants in 87 countries (shown in green). The dots represent grants made in 2008. Grants in Africa were made before the establishment of UAF's Sister Fund UAF-Africa in 2003; all Rapid Response Grantmaking on the continent of Africa has since been managed by UAF - Africa.

RAPID RESPONSE GRANTS IN 2008

Altufula: Pedagogical and Multipurpose Women's Center, Israel: \$5,000

Provided funds to recreate real-time feminist responses to escalating violence in the region.

Anti-Violence Network of Georgia, Georgia: \$4,900

Provided funds to document human rights violations committed against women during the conflict in Georgia in order to present these findings before the European Union Court and Hague Military Tribunal.

Asia Pacific Network of Sex Workers, Cambodia: \$5,000

Supported an awareness raising campaign in response to a newly implemented law that criminalizes prostitution in Cambodia and has resulted in widespread violations against women sex workers.

Asociación De Mujeres Amor Lesbico, Bolivia: \$4,150

Enabled group to increase the security of threatened activists and organize an awareness raising campaign after anti-government protests became violent and targeted groups, including members of AMAL.

Asociación De Mujeres Amor Lesbico, Bolivia: \$3,800

Provided an additional grant to increase the protection and security of threatened lesbian activists.

Asociación de Mujeres para la Integración de la Familia en Nicaragua, Nicaragua: \$5,000

Supported a massive mobilization and awareness raising campaign to respond to increasing violence and political repression in Nicaragua.

Asociación Instituto Vida, Peru: \$2,700

Supported an awareness raising campaign regarding an escalation in state persecution after three women activists were labeled as 'terrorists' for organizing a peaceful protest.

Association "Women and Development", Georgia: \$2,980

Provided funds to respond to the post-conflict environment in Georgia's buffer zones via an education campaign highlighting how women can increase their security during occupation.

BARGAD, Pakistan: \$5,000

In response to the unanticipated repeal of a 24-year ban on student unions, UAF supported BARGAD to advocate for a precedent-setting 33% quota for women students in university unions.

Blue Veins (Women Welfare and Relief Services), Pakistan: \$5,000

Enabled group to purchase a vehicle to provide safe transportation for women members of the organization facing increasing threats and harassment from religious militant extremists.

Bridge of Friendship "Kartlosi", Georgia: \$3,410

Enabled group to react to the conflict in Georgia by organizing a peaceful protest and ensuring that human rights violations against women are documented.

Centro de la Mujer Acción Ya, Nicaragua: \$5,000

Supported an awareness raising campaign to address the government crackdown on women's rights organizations and nine activists who were facing an escalation in threats.

Centro Ecuatoriano para la Promoción y Acción de la Mujer, Ecuador: \$5,000

In response to the unexpected backlash by the Catholic Church following a newly proposed pro-choice amendment, UAF funded CEPAM to initiate an awareness raising campaign to highlight the importance of women's reproductive rights.

Centro Ecuatoriano para la Promoción y Acción de la Mujer, Ecuador: \$5,000

In response to the unanticipated escalation of anti-rights groups' pressure on the government, UAF supported CEPAM's awareness raising campaign to ensure that the rights of women and minority groups are included in Ecuador's revised constitution.

Corporación Contigo Mujer, Colombia: \$5,000

Provided funds to increase the protection and security of a woman activist threatened due to her work.

Corporación Contigo Mujer, Colombia: \$5,000

Provided funds to ensure that a trial against Indigenous women arrested after performing female genital cutting, a practice thought to have been eradicated in Colombia was culturally competent and fair.

DAH Theatre Research Center, Serbia: \$4,920

Provided funds to increase the security of the DTRC office after a theft and arson occurred in response to their political theater performances denouncing militarism, nationalism and gender inequality.

In addition to the 124 grants made directly by UAF, 39 Rapid Response Grants were made in 2008 by UAF's regranting partners in Colombia (26), Serbia (9) and a confidential location (3).

Provided funds to increase the protection and security of a woman activist threatened due to her work.

Federation of Suara Bangsamoro Women Organizations, Philippines: \$4,475

Provided funds to increase the security of a threatened woman human rights defender.

Fondo para Ayudas de Emergencia y Fortalecimiento Organizacional en Protección y Autoprotección, Colombia: \$25,000

Supported the re-granting partnership established in 2006 and enabled FFP to continue their rapid response grantmaking program on behalf of threatened women activists in Colombia.

Provided funds to increase the security of members of FFP who were facing an escalation of threats.

Supported a campaign in response to the unanticipated announcement to rescind the Coastal Zone Management Notification, which would have a deleterious impact on women and the environment.

Grass-roots Women for Change, Cambodia: \$5,000

Supported an awareness raising campaign to ensure women leaders are involved in a precedent-setting case to support the struggle for land rights.

Helsinki Committee For Human Rights, Serbia: \$5,000

Provided funds for the security of the threatened woman leader of the organization.

Karapatan Task Force on Women and Children, Philippines: \$4,200

Provided funds to increase the protection and security of a woman activist threatened because of her human rights work.

Kay Fann, Haiti: \$5,000

Supported an awareness raising campaign to pressure the government to respond to the increase in sexual violence against women due to the lawlessness and impunity in post-hurricane Haiti.

Khadidja-Davao, Philippines: \$5,000

Provided funds to increase the protection and security of a threatened woman activist.

Khadidja-Davao, Philippines: \$3,700

Provided funds to increase the safety of a Moro woman human rights defender facing threats.

Supported an awareness raising campaign in the months leading up to the constitutional referendum, to highlight precedent-setting changes to the Bolivian constitution to secure political, cultural, and economic rights for women and Indigenous peoples.

Supported an awareness raising campaign regarding the potentially precedent-setting legal case to prosecute the perpetrators of hate crimes committed during the Queer Belgrade Festival in September 2008.

Enabled group to respond to an escalation of the conflict between the Moro Islamic Liberation Front and the Philippine Armed Forces through an anti-war campaign and a fact-finding mission to document abuses against women in Moro Muslim dominated areas.

Provided funds to prepare affidavits for the unexpected announcement that the Inter-American Commission on Human Rights will review the case against Nicaragua's ban on therapeutic abortions.

Supported an awareness raising campaign to highlight the murder of a woman human rights defender targeted because of her anti-violence against women work.

Supported an awareness raising campaign to draw national and international attention to the government's crackdown on women's rights organizations and nine individual women activists.

Movimiento por la Defensa de la Anticoncepción, Chile: \$5,000

Supported a campaign to raise awareness regarding women's reproductive rights after the prohibition of emergency contraception was unexpectedly announced by the Chilean Constitutional Court.

Mujer Sin Límite, Honduras: \$5,000

Provided funds to increase the security of their organization after hate crimes left their office's security system destroyed.

Mujer Sin Límite, Honduras: \$5,000

Provided funds to increase the security of lesbian and bisexual activists facing increased threats.

Enabled group to increase the protection of a woman human rights defender facing increased threats due to her activism on behalf of the Zapara Indigenous community.

Supported a grassroots awareness raising campaign to ensure women are aware of the precedent-setting opening of a "Pro-Life" pharmacy in their community and to collectively contest it.

Supported a campaign to oppose the Mongolian parliament's unanticipated decision to repeal the 30% quota for women candidates in parliamentary elections.

New Generation of Women's Initiatives, Lithuania: \$5,000

Supported a campaign in favor of women's reproductive rights in reaction to an anti-choice bill, which was unexpectedly introduced in the Lithuanian parliament.

Nirmaya Trust, India: \$5,000

Provided support of women's peacebuilding initiatives in response to unanticipated communal violence in Orissa.

Novi Sad Lesbian Organization, Serbia: \$2,320

Provided funds to increase the security of NLO's office after a highly publicized lesbian festival resulted in threats against the organization.

Organization Q, Bosnia: \$5,000

Provided funds to increase the security of their Queer Sarajevo Festival after receiving threats in the days leading up to the event.

Red Flag Women's Movement, Sri Lanka: \$2,900

Supported an awareness raising campaign to promote the rights of domestic workers in response to an unanticipated decision by the government to streamline Sri Lanka's labor laws.

Rural Poor Women's Apostolate - Northern Mindanao, Philippines: \$5,000

Enabled group to provide increased security for RMP's main organizer and to launch an awareness raising campaign to highlight government aggression against women human rights defenders.

Provided funds to ensure grassroots women's voices are included in the implementation of a precedent-setting decree, which aims to increase the rights of displaced women via trainings and an awareness raising campaign.

Supported theater forums on LGBTIQ and women's rights in response to an unanticipated revision of Puerto Rico's Civil Code that would erode previously earned gains.

Vida Integración Desarrollo Amor, Peru: \$2,850

Provided funds to increase the security of activists who were attacked after an action celebrating International Day for Human Rights, and to launch an awareness raising campaign condemning hate crimes against the LGBTIQ community.

Voice of Difference, Serbia: \$4,900

Supported a campaign to encourage Serbian women to vote in upcoming early elections in the midst of an increasingly nationalistic and isolationist political environment.

Women Against War, Israel: \$5,000

Provided funds to mobilize a peaceful protest against the Israeli invasion and attacks on the Gaza Strip.

Capabilities/Skills/Strength, Palestine: \$5,000**

Supported an awareness raising campaign regarding the escalation of violence in Gaza, including Hamas' crackdown on 120 local NGOs, resulting in the destruction of ZAKHER's office.

International Network of Women's Funds (INWF), Global: \$10,000

Support for INWF's commitment to expanding the resources available to women's rights organizations worldwide.

Funding to support this international initiative for the recognition and protection of women human rights defenders.

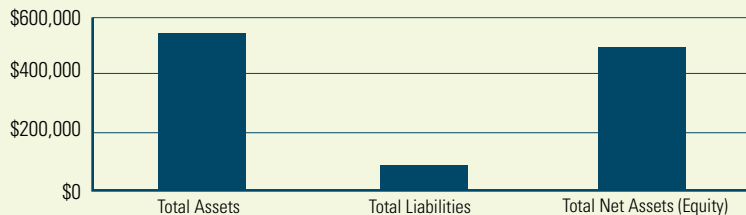

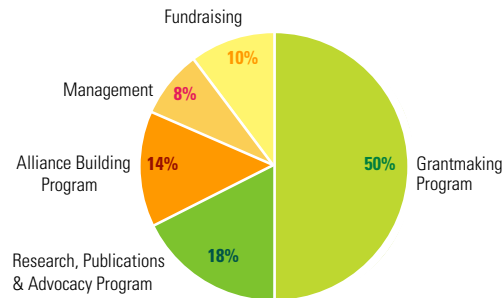

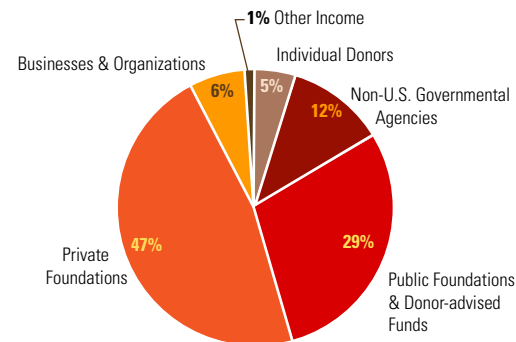
